The exhibition is open to artists in all media from Franklin and Gulf Counties. Each artist may enter NO MORE than two recent pieces for consideration.

**ENTRY RULES**

Entry fee is \$20 and is non-refundable. Make checks payable to St. George Plantation Owners Association, Inc. All works entered must be original creations by the artist and must be **show ready** for presentation. Two-dimensional pieces must be wired for hanging. Maximum size accepted for two-dimensional work is 72" by 72". Three-dimensional works must not exceed 8' in height, cover more than six square feet of floor area, or weigh more than 150 lbs.

Work can be offered or sale during the show. The artist gallery can also be indicated. The Plantation reserves the right to provide the media with reproductions of the exhibited artwork from this exhibition.

**JURYING PROCESS**

Accepted artists will be notified via email.
